The doctrine, especially in Hispanoamerica, widely acknowledges that a discipline is not fully autonomous until it achieves jurisdictional independence. Various international bodies and organisations have called for the convenience of a separate jurisdictional order or specialised agrarian courts. The aim of this international congress is to promote this process, is to introduce new aspects that will promote this idea, to substantiate it legally and to make a defence of it all. It is a matter of proposing a methodology for its implementation, determining the facts acts and conducts that these courts would hear. The advantages and benefits of specialised agricultural and agri-environmental courts will also be brought to bear. Undoubtedly, an important contribution to the implementation of these courts comes from the property and commercial Registers.
